This document provides you with a summary of the process involved when booking a safari. Included in this document is the **Booking Form** which contains essential information required by us, and an **Insurance Application** form.

① PAYMENT

- To confirm your travel arrangements, a \$1000.00 non-refundable **Deposit** is required.
- The **Balance/Final payment** is due 60 days prior to your departure date.
- The **Invoice** highlights the payment amounts due and the dates these are due.

Credit Card - we reserve the right to charge a 2% administration fee imposed upon us by the credit card companies. This fee is added to the total value of the arrangements. *Should you wish to use a credit card, please request a Credit Card Authorisation Form*

③ TRAVEL INSURANCE

CHI Insurance is the policy offered by The Classic Safari Company. Comprehensive travel insurance is recommended. It is advisable to obtain insurance at the time of confirmation/paying the deposit.

If you have a *pre-existing medical condition* or are *over the age of 80*, you do need to fill out a 'pre-existing medical condition' form. This form can be obtained from The Classic Safari Company and needs to be signed by a doctor and returned to The Classic Safari Company, then CHI, before a policy can be issued.

Non-residents, or Australian residents who have already departed Australia, are ineligible to purchase CHI insurance.

For your safari you will need to be covered for 23 days. Travel to Africa is covered under AREA1. Currently the premium (with no excess) is A\$232 per person. The rate sheet for all policies can be reviewed on page 6.

④ FLIGHT ARRANGEMENTS

If The Classic Safari Company is booking flight arrangements, it is essential that Passport Surname & First Names are provided prior to making flight bookings.

⑤ PRE-DEPARTURE INFORMATION

On confirmation of your arrangements, the following will be issued:

- a pre-departure information booklet
- a confirmed itinerary
- an invoice highlighting the balance due and the date this is due

⑥ TRAVEL DOCUMENTATION

Once the balance/final payment has been received, 21 days prior to your departure from Australia you will be issued with the following:

- itinerary with operator contact details, including a copy for friends/relatives
- air tickets/e-tickets (*if purchased through The Classic Safari Company*)
- travel insurance certificate and policy (*if purchased through The Classic Safari Company*)
- travel vouchers (*if applicable*)

Terms & Conditions

PREAMBLE

When a booking is confirmed with 2Max Investments Pty Ltd, trading as The Classic Safari Company, a contract between either the travel agent or the travelling client is constituted. This contract is subject to the conditions below.

DEPOSITS

A booking may only be secured by completion of this booking form, and payment of a non-refundable deposit of 30% of the value of the land travel arrangements. If confirming a tour within 8 weeks of travel, The Classic Safari Company reserves the right to request payment in full at that time. Please also note that if travel insurance is taken out at the time of paying a deposit, you will typically be protected against any forfeiture of the deposit in the event of a bona fide cancellation. Travel insurance costs are over and above the required deposit.

CREDIT CARDS

We accept Visa, Mastercard, American Express & Diners for credit card payments. These will incur an additional service fee of 2%. This is calculated on the total transaction value.

FINAL MONIES

The date for payment of final monies will be indicated on invoices sent to you. If final monies are not received on the due date, The Classic Safari Company reserves the right to treat the booking as cancelled and to apply the appropriate cancellation charges set out below.

EXCHANGE RATES & PRICING

The Classic Safari Company normally pays for travel arrangements in overseas currencies. In addition, the exact nature of overseas suppliers can vary. For this reason, The Classic Safari Company offers customised packages of land and/or air services – priced according to exchange rate fluctuations, supplier commission levels and other services provided by The Classic Safari Company. Payment of a deposit constitutes acceptance of such an approach and acknowledgement of the fact that a package of services is being purchased and paid for in the currency involved.

ITINERARY CHANGES AFTER CONFIRMATION & ONCE TRAVELLING

The Classic Safari Company hereby reserves the right to charge AUD50 per change made by a client to a confirmed itinerary, in addition to any cancellation or other charges levied by overseas operators or airlines. The Classic Safari Company also reserves the right to make changes to an itinerary, provided reasonable justification is provided, and that suitable and comparable alternative arrangements are found. The Classic Safari Company cannot be held responsible for changes to itineraries and accommodation made by ground operators as a result of inclement weather or unexpected situations such as civil unrest.

CANCELLATION CHARGES

All cancellations must be notified in writing to The Classic Safari Company and will take effect on the date of receipt of such notice by The Classic Safari Company. All travel arrangements are prima facie subject to the following cancellation charges:

- 60 days or more prior to departure - forfeit of deposit;
- 60 and 30 days prior to departure - forfeit of 50% of the total value of arrangements;
- 30 days or less prior to departure - forfeit of the value of all arrangements.

This cancellation policy may vary for some tour operators. This will be indicated in the relevant tour operator's booking conditions.

Airfare cancellation charges will be in accordance with Airline Tariff Regulations, plus any handling or other fees charged to The Classic Safari Company.

REFUNDS

There is prima facie no refund on the unused portion of any tour once confirmed and commenced. Other refunds will be handled on a case by case basis.

TRAVEL INSURANCE

Comprehensive travel insurance is strongly recommended by The Classic Safari Company, however any decision not to insure must be made by you, and at your risk. In the case that you do not purchase travel insurance through The Classic Safari Company, it is necessary that you provide us with details of an alternative policy or acknowledge that you do not wish to obtain insurance.

PASSPORTS & VISAS

Clients must be in possession of a valid passport (with 6 months validity). Visas may be required to complete your tour and are your responsibility. Visa requirements are subject to change without notice. All information on passport & visa requirements is provided by The Classic Safari Company in good faith but without responsibility.

LOCAL CONDITIONS

Holidays in destinations packaged by The Classic Safari Company can be affected by changes in local conditions and unpredictable events. Outages in basic infrastructure, fuel shortages, poor road conditions, inclement weather and other unforeseen problems can occur. Such circumstances, as well as war, terrorist activity, industrial action, or force majeure events are outside of the control of The Classic Safari Company, and liability for them in any way whatsoever is hereby disclaimed. However, should such circumstances transpire, The Classic Safari Company will assist where possible to secure alternative accommodation or travel arrangements, but hereby disclaims any liability for payment of such alternative arrangements.

AMBIT OF RESPONSIBILITY OF The Classic Safari Company.

The Classic Safari Company acts only as agent for the passenger with respect to services provided by underlying operators, including hotels, airlines, lodges, restaurants, road transport providers, canoe and rafting operations, professional guides, air charter services, and climbing activities. All bookings with The Classic Safari Company are therefore subject to the limitations of liability imposed by the underlying operators involved in the tour. The Classic Safari Company will nonetheless exercise due care in the preparation of an itinerary, however, specifically disclaims responsibility for any loss, injury, accident, delay or death arising from the tour in question.
